The undersigned incorporator of A A A CONSTRUCTORS, INC., pursuant to the Florida General Corporation Act, adopts the following Articles of Incorporation.

ARTICLE I. NAME

The name of the corporation is A A A CONSTRUCTORS, INC.

ARTICLE II. COMMENCEMENT OF EXISTENCE

The existence of the corporation is to commence on the day these Articles are accepted for filing.

ARTICLE III. PURPOSE

The corporation is organized for purposes of performing general contracting, and transacting any other lawful business.

ARTICLE IV. CAPITAL STOCK

The corporation is authorized to issue 1,000 shares of participating and voting \$.01 par value Common Stock. The consideration to be paid for each share shall be fixed by the Board of Directors and may be paid, in whole or in part, in cash or other property, tangible or intangible, or in labor or services actually performed for the corporation with a value, in the judgment of the directors, equivalent to or greater than the full par value of the shares.
