ARTICLE 1: NAME AND MAILING ADDRESS

The name of this Corporation is JERRY STERN & ASSOCIATES, INC., and its principal office or mailing address is 1288 - 80th Street South, St. Petersburg, Florida 33707.

ARTICLE 2: DURATION

This Corporation shall exist perpetually, commencing as of the date of acceptance and filing of these Articles by the Secretary of State of the State of Florida.

ARTICLE 3: PURPOSE
