ARTICLES OF INCORPORATION

OF

KULUKUNDIS-POSNER, INC.

The undersigned, for the purpose of forming a corporation under the provisions of the Florida General Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE I. NAME. The name of this Corporation is KULUKUNDIS-POSNER, INC.

ARTICLE II. DURATION. This Corporation shall have perpetual existence.

ARTICLE III. PURPOSE. This Corporation is organized for the purpose of transacting any and all lawful business for which corporations may be incorporated under the Florida General Corporation Act.

ARTICLE IV. CAPITAL STOCK. This Corporation is authorized to issue One Hundred (100) shares of \$1.00 par value, Common Stock.

ARTICLE V. INITIAL REGISTERED OFFICE AND AGENT. The street address of the initial registered office of this Corporation is 7251 West Palmetto Park Road, Suite 200Z, Boca Raton, Florida, 33441, and the name of the initial registered agent of this Corporation at that address is MARC H. HOFFMAN, P.A., a Florida corporation.

ARTICLE VI. PRINCIPAL OFFICE. The mailing address of this Corporation shall be: Suite 175, 800 Fairway Drive, Deerfield Beach, Florida 33441.

ARTICLE VII. INITIAL BOARD OF DIRECTORS. This Corporation shall have one (1) Director initially. The number of directors may be increased from time to time in accordance with the By-Laws, but shall never be less than one. The name and address

of the initial Director of this Corporation is: ANGELA KULU-KUNDIS, 800 Fairway Drive, Suite 175, Deerfield Beach, Florida 33441.

ARTICLE VIII. INCORPORATOR. The name and address of the person signing these Articles of Incorporation as the incorporator of this Corporation is: TERESA ROMAN, 2805 Little Deal Road, Tallahassee, Florida 32308.

ARTICLE IX. COMMENCEMENT OF CORPORATE EXISTENCE. This Corporation shall be deemed to commence its existence upon the filing of these Articles of Incorporation by the Florida Department of State.

ARTICLE X. PREEMPTIVE RIGHTS. The shareholders shall have preemptive rights in any transfer of any stock of this Corporation.

ARTICLE XI. INDEMNIFICATION. The Corporation shall indemnify any Officer or Director, or any former Officer or Director, to the full extent permitted by law.

ARTICLE XII. AMENDMENT. This Corporation reserves the right to amend or repeal any provision contained in these Articles of Incorporation, or any amendment hereto, and any right conferred upon the shareholders is subject to this reservation.

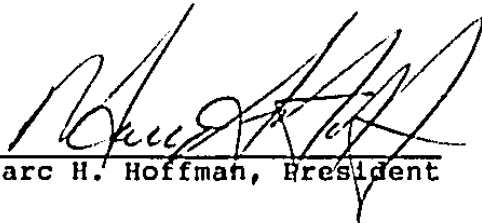
ACCEPTANCE BY REGISTERED AGENT
