The undersigned, who is duly licensed to practice law in the State of Florida, desires to form a professional corporation in accordance with Chapter 607 of the Florida Statutes and the Florida Professional Service Corporation act and hereby adopts the following Articles of Incorporation for the purpose of forming a corporation under the laws of the State of Florida.

ARTICLE 1 - NAME AND PRINCIPAL LOCATION

The name of the corporation is: CHARLENE D. KELLEY, P.A.
