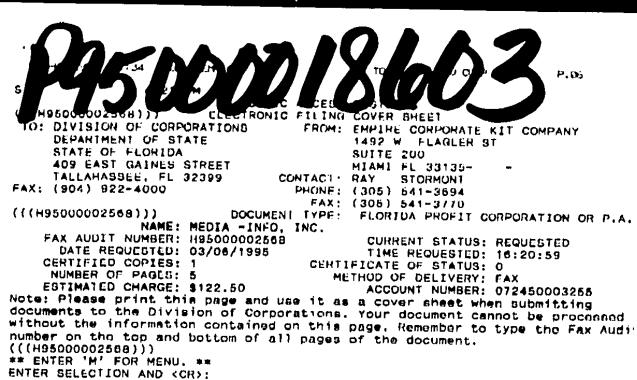

ARTICLES OF INCORPORATION OF MEDIA-INFO. INC.

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Curporation Act, hereby adopt the following Articles of Incorporation.

ARTICLE I - NAME
