#### ARTICLE I-NAME

The name of the corporation is DIVERSIFIED TELECOMMUNICATIONS AGENCY, INC.

#### ARTICLE II - DURATION

This corporation shall exist perpetually, commencing at the time of filing these articles with the Secretary of State of the State of Florida.

#### ARTICLE III -PURPOSES
