ARTICLES OF INCORPORATION
OF

ARTICLE I - NAME

The name of this Corporation is THE TEXPERT GROUP, INC.

The person signing these articles is RAUL R. DELGADO DE ARMAS, ESQUIRE, Registered Agent.

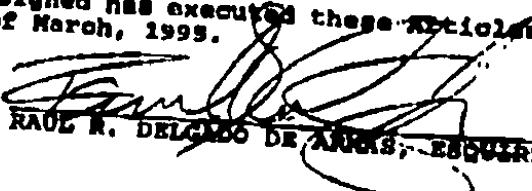
ARTICLE XI - OFFICES

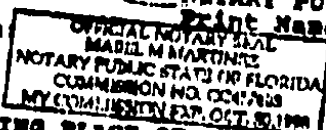
