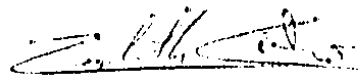

The undersigned incorporator, for the purpose of forming a Professional Association under the laws of the State of Florida, adopts the following articles of incorporation.

### ARTICLE I

#### NAME OF PROFESSIONAL ASSOCIATION
