ARTICLES OF INCORPORATION OF GEORGE CONIGLIO RECYCLING/LANDFILL, INC.

#### ARTICLE ONE

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation.

## ARTICLE TWO

The duration of the corporation is perpetual unless sooner dissolved according to law.

## ARTICLE THREE

The general purposes for which the corporation is organized are:

- To engage in the business of construction debris and demoliation recycling and operating a landfill.
- 2. To engage in any other trade or business which can, in the opinion of the Board of Directors of the Corporation, be advantageously carried on in connection with or auxiliary to the foregoing business.
- 3. To do such other things as are incidental to the foregoing or necessary or desirable in order to accomplish the foregoing.

#### ARTICLE FOUR

is equivalent to the par value thereof; said stock may be paid for in money, property, labor or services at a just valuation to be fixed by the Board of Directors or issued as partly paid when so ordered by the Board of Directors.

### ARTICLE FIVE

This corporation shall take all action necessary to cause the shares of corporate stock to qualify as "Section 1244 Stock" as such term is used and defined in the Internal Reveune Code of 1954, as amended, and the regulations issued thereunder.

### ARTICLE SIX

The street address of the initial office of the corporation is 11981 North Williams Road Thonotosassa, Florida 33592 and the name of the intial registered agent at such address is George Coniglio.

## ARTICLE SEVEN

The number of directors of this corporation shall be not less than **EATE** (1) nor more than five (5). The number to compose said Board shall be fixed by the Stockholders at each annual meeting to be effective for the ensuing year, unless sooner changed at a meeting of said Stockholders for that purpose.
