The undersigned hereby adopts the following Articles of Incorporation for the purpose of forming a corporation under the laws of the State of Florida.

ARTICLE I - NAME AND PRINCIPAL LOCATION

The name of the corporation is: **ADVANTAGE CURBS, INC.**

The principal place of business of this corporation shall be 1681-B South County Rd. 427, Altamonte Springs, Fl. 32715. The mailing address of the corporation shall be P O Box 947527, Maitland, FL 32794-7527.

ARTICLE II - EXISTENCE

The term of existence of the corporations is perpetual.

ARTICLE III - PURPOSE

The purpose for the corporation is to conduct curbing and sidewalk installation and for all other legal purposes under the Laws of the State of Florida.
