THE UNDERSIGNED incorporator, for purposes of forming a professional service corporation under Chapter 621 of the Florida Statutes hereby adopts the following Articles of Incorporation:

FIRST: The name of the corporation is DANA TURKEN, C.P.A., P.A. (the "Corporation").

SECOND: The principal office and mailing address of the Corporation is 100 4th Terrace, Dilido Island, Miami Beach, Florida 33139.

THIRD: The Corporation is authorised to issue 10,000 shares of common stock, par value \$.01 per share.
