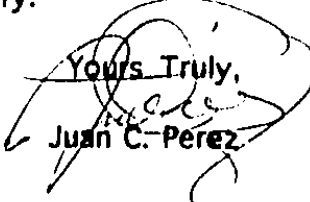

ARTICLE I - NAME

The name of this Corporation is Jose & Jose Plaster

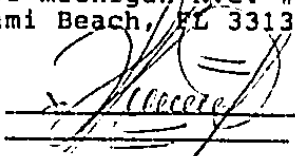

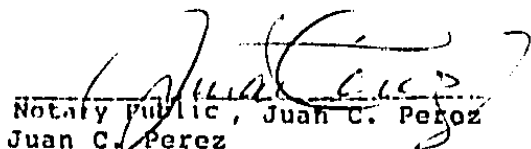
