The undersigned, CASEY JOHNSON subscriber to these Articles of Incorporation, being a natural person over the age of eighteen (18) years of age, competent to contract, hereby presents these Articles for the formation of a Corporation under the laws of the State of Florida.

ARTICLE I. NAME OF CORPORATION

The name of the Corporation shall be EMERALD PROPERTIES OF PINELLAS COUNTY, INC.
