ARTICLE I - NAME - LOCATION

The name of this corporation is SHESKIN, INC., located at 4335 Ocean Drive (A1A), Lauderdale-by-the-Sea, Florida 33308.



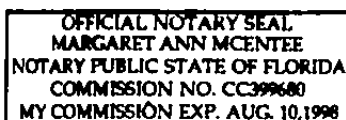
