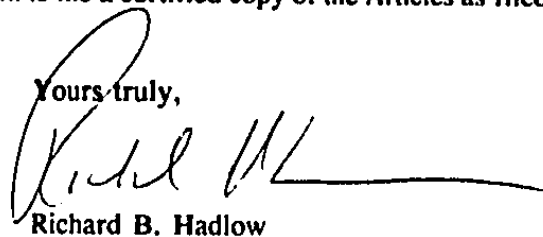

The undersigned, acting as incorporator of the captioned corporation under the Florida
Business Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I

EFFECTIVE DATE

Corporate Name and Principal Office

The name of this corporation is WORLD-LINK CONNECTIONS, INC. and its principal
office and mailing address is 13630 58th Street North, Suite 103, Clearwater, FL 34620.

ARTICLE II

Commencement of Corporate Existence

The corporation shall come into existence on the date of subscription and
acknowledgment of the Articles of Incorporation.

ARTICLE III

General Nature of Business

The corporation may transact any lawful business for which corporations may be
incorporated under Florida law.

ARTICLE IV

Capital Stock
