

ARTICLES OF INCORPORATION

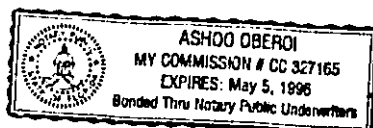
The undersigned, for the purpose of organizing a Florida Profit Corporation adopt the following Articles of Incorporation:


- 1) The name of the corporation is Takeoff Estimating Service, Inc.
