ARTICLES OF INCORPORATION

OF

T.V. LYNCH ROOFING & GENERAL CONTRACTING INC.

The undersigned subscriber to these Articles of Incorporation is a natural person competent to contract and hereby form a Corporation for profit under Chapter 607 of the Florida Statutes.

ARTICLE 1 - NAME

The name of the Corporation is T.V. LYNCH ROOFING & GENERAL CONTRACTING, INC.

ARTICLE 2 - PURPOSE OF CORPORATION

The Corporation shall engage in any activity or business permitted under the laws of the United States and of the State of Florida.

ARTICLE 6 - CORPORATE CAPITALIZATION
