#### ARTICLES OF INCORPORATION

OF

# MAZE MASTER MIKE ENTERPRISES, INC.

The undersigned, for the purpose of forming a corporation under Chapter 607, Florida Statutes, does hereby adopt the following Articles of Incorporation:

## ARTICLE I: NAME

The name of the Corporation is MAZE MASTER MIKE ENTERPRISES, INC.

# ARTICLE II: DURATION

The period of duration of the Corporation is perpetual unless dissolved according to law. Corporate existence shall commence upon the filing of these Articles of Incorporation.
