**ARTICLES OF INCORPORATION
OF
MURRAY COORDINATING CONSULTANTS, INC.**

We, the undersigned, being of sound mind and legal age, do hereby agree for ourselves and our assigns to become a corporation for profit under the laws of the State of Florida, providing for the formation, liability, rights, privileges, benefits and obligations conferred and imposed by such laws on corporations organized pursuant to the provisions thereof, and do hereby make, subscribe, acknowledge and agree to and file these Articles of Incorporation as follows:

ARTICLE I. NAME

The name of the corporation is **MURRAY COORDINATING CONSULTANTS, INC.**

ARTICLE II. DURATION

This corporation shall have perpetual existence. The corporation's existence shall commence on the date of execution and acknowledgement of these Articles.

ARTICLE III. PURPOSE

The general nature of the business to be transacted by this corporation is to include any and all lawful business for which corporations may be incorporated under the Florida General Corporations Act.

ARTICLE IV. STOCK
