## ARTICLES OF INCORPORATION

OF

## SOUTHEAST NETWORK SERVICES INC.

The undersigned, for the purpose of forming a corporation for profit under the laws of Florida, hereby adopts the following Articles of Incorporation:

#### **ARTICLE 1**

## Name and Principal Place of Business

The name of the corporation is Southeast Network Services Inc., and the principal place of business is 12128 Banyon Tree Drive, Jacksonville, Florida 32258.

#### ARTICLE II

#### Duration

This corporation shall exist perpetually, commencing upon the filing of these Articles with the Secretary of State of the State of Florida.

## **ARTICLE III**

### Nature of Business

This corporation is organized for the purpose of transacting any or all lawful business.

#### **ARTICLE IV**


#### Capital Stock

This corporation is authorized to issue 1000 shares of \$.00 per value common stock which shall be designated "Common Shares."

#### **Bylaws**

Any director of the corporation may also serve the corporation in any other capacity and receive compensation therefor in any form.

## **ARTICLE XII**

## Indemnification

The Board of Directors is hereby specifically authorized to make provisions for indemnification of directors, officers, employees and agents to the full extent permitted by law.

## **ARTICLE XIII**

#### Amendment

This corporation reserves the right to amend or repeal any provision contained in these Articles of Incorporation, or any amendment hereto, and any right conferred upon the shareholders is subject to this reservation.
