The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation.

#### ARTICLE I NAME

The name of the Corporation is MHG, Inc..

## ARTICLE II DURATION

The duration of the Corporation is perpetual.

# ARTICLE III PORPOSES OF BUSINESS

The general purposes for which the Corporation is organized are:
