ARTICLES OF INCORPORATION
OF
HOLLYWOOD & LAWN CARE, INC.

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, do hereby adopt the following Articles of Incorporation:

Article I - Name

The name of this corporation is HOLLYWOOD & LAWN CARE, INC. The principal place of business of this corporation shall be 4112 W. Marshall, Tampa, Florida. Other offices or places may be designated by the Board of Directors.

Article II - Capital Stock

This Corporation shall have the authority to issue one hundred shares of common stock, no par value.

Article III - Initial Registered Office and Agent

The initial address of the office of the corporation shall be 4112 W. Marshall, Tampa, Florida. The person to whom all communications to the corporation shall be made shall be the person named as the initial registered agent of the corporation.

Article IV - Incorporation
