ARTICLES OF INCORPORATION
OF
FIONTE PRODUCTIONS, INCORPORATED

The undersigned, acting as incorporator of Fionte Productions, Incorporated, under the Florida Business Corporation Act, adopts the following Articles of Incorporation.

ARTICLE I
NAME

The name of the corporation (the "Corporation") is Fionte Productions, Incorporated.

ARTICLE II
ADDRESS
