Articles of Incorporation of CYBERCARE Corporation

The undersigned, acting as incorporator of this Corporation pursuant to Chapter 607 of the Florida Statutes, hereby forms a corporation for profit under the laws of the State of Florida and adopts the following Articles of Incorporation for such Corporation

Article 1 - Name of Corporation

The name of this Corporation shall be **CYBERCARE Corporation**.

Article 2 - Principal Office

The principal office of this Corporation shall be located at **5412 Westview Drive, Orlando, Florida, 32811**.

Article 3 - Capital Stock

The maximum number of shares of capital stock that this Corporation is authorized to issue and have outstanding at any one time is **One Thousand (1,000) shares of common stock having a par value of One Cent (\$0.01) per share**

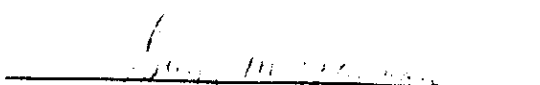

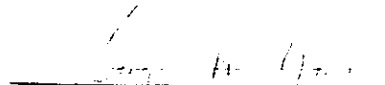
