Name. The name of this Corporation is SIXTH STREET GNCP ASSOCIATION, INC.

Article II

EFFECTIVE DATE

Duration. The period of duration of this Corporation shall be perpetual, commencing on the date of execution of these articles.

Purpose. 

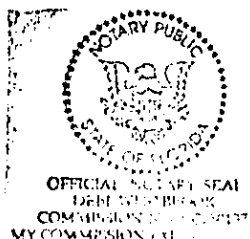
