NAME

The name of the corporation shall be:

DURATION

The corporation shall commence its existence on March 9, 1995, and shall exist perpetually unless sooner dissolved according to law.

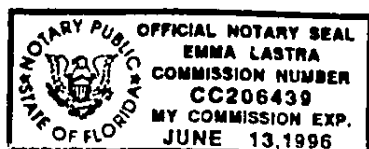
