ARTICLE I - BILL CADRECHA AND ASSOCIATES, INC., 1300 E. 7th Ave, Tampa, Florida 33605.

The name of this corporation is BILL CADRECHA AND ASSOCIATES, INC. and its principal place of business shall be located at 1300 E. 7th Ave, Tampa, Florida 33605.
