ARTICLES I

THE NAME OF THIS CORPORATION SHALL BE: CHETICAMP COMMUNICATIONS, INC.

ARTICLES II

THE STREET ADDRESS IN THIS STATE OF THE PRINCIPAL
OFFICE OF THIS CORPORATION SHALL BE: 800 W.OAKLAND PK.BLVD.

ARTICLES III

THE CORPORATION SHALL HAVE PERPETUAL EXISTENCE, COMMENCING WITH THE DATE OF FILING OF THESE ARTICLES.

ARTICLES IV

THE GENERAL NATURE OF THE BUSINESS TO BE CONDUCTED BY THIS CORPORATION SHALL BE: SERVICES RELATING TO TELECOMMUNICATIONS
