The undersigned, acting as incorporator of a corporation under Florida General Corporation Act, adopts the following Articles of Encorporation for such corporation:

ARTICLE I

The period of duration of the corporation is perpetual.

ARTICLE VIII

The shareholders shall have the power to adopt, amend, alter, change, or repeal the Articles of Incorporation when proposed and approved at a stockholden's meeting, with no less than a two-thirds vote of the common stock.

ARTICLE X
