ARTICLES OF INCORPORATION

ARTICLE I - NAME

The name of this corporation is **KOSME ENTERPRISES, INC.**

ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on the date of the filing of these Articles with the Department of State.

ARTICLE III - PURPOSE
