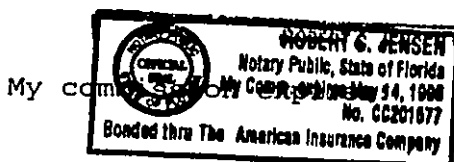

SECOND: The articles of incorporation were filed on March 10, 1995.


