

ARTICLES OF INCORPORATION OF

ARTICLE I - NAME

The name of this Corporation is JSE ENTERPRISES, INC.,

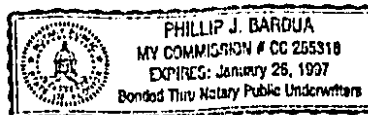
