# **ARTICLES OF INCORPORATION**

OF

# WATER TREATMENT SYSTEMS, INC.

Control of the State of the Sta The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

#### ARTICLE ONE

The name of the Corporation is WATER TREATMENT SYSTEMS, INC.

#### **ARTICLE TWO**

The duration of the Corporation is perpetual.

#### **ARTICLE THREE**

The general purposes for which the Corporation is organized are:

- 1. To transact any lawful business for which corporations may be incorporated under the Florida General Corporation Act.
- 2. To do such other things as are incidental to the foregoing or necessary or desirable in order to accomplish the foregoing.
