ARTICLES OF INCORPORATION **OF** GULF COAST CLEANING SERVICES, INC.

ARTICLE I. NAME

The name of this corporation is:

Gulf Coast Cleaning Services, Inc.

ARTICLE II. NATURE OF BUSINESS AND POWERS

The general nature of the business to be transacted by this Corporation is to engage in any and all business as permitted under the laws of the State of Florida.

ARTICLE III. CAPITAL STOCK
