

THIRD: The date of each amendment's adoption: September 29, 1997



FINAL JUDGMENT OF DISSOLUTION OF MARRIAGE

THIS CAUSE having come on for final hearing and the Court being fully advised in the premises, makes the following findings of fact:

1. The Court has jurisdiction of the parties and subject matter of this action.
2. The parties were married to each other on September 30, 1989, at St. Lucie County, Florida.
3. The Petitioner has been a resident of the state of Florida for more than six months prior to the filing of the Petition for Dissolution of Marriage.
4. The marriage between the parties is irretrievably broken.
5. There have been two children born to the marriage, to wit: JOHNNIE GRAY CORDEIRO, date of birth: March 4, 1986; and ANGELITA CORDEIRO, date of birth: January 20, 1991.
6. The parties shall have shared parental responsibility for the two minor children. The Husband shall be designated the primary residential parent of the minor children. The Wife

shall be entitled to reasonable and liberal visitation of both minor children, with the minimum being set forth in the standard St. Lucie County visitation schedule.

7. Child support is agreed to by the parties as specifically set forth in the Marital Settlement Agreement. The Wife shall pay child support in the amount of \$350.00 per month, commencing on June 1, 1997, directly to the Husband.

8. The parties have entered into a Marital Settlement Agreement dated April 1, 1997, resolving all issues and disposing of all their property and debts. The original Marital Settlement Agreement has been filed with the Court on July 9, 1997.

9. That the Wife's maiden name is Terri Lynn Scott.

It is hereby ORDERED and ADJUDGED as follows:

A. The Petitioner has been a resident of the state of Florida for more than six months prior to the filing of the Petition for Dissolution of Marriage.

B. The bonds of marriage between the Husband, LEO CORDEIRO, and the Wife, TERRI CORDEIRO, are dissolved.

C. There have been two minor children born to the marriage, to wit: JOHNNIE GRAY CORDEIRO, date of birth: March 4, 1986; and ANGELITA CORDEIRO, date of birth: January 20, 1991.

D. The parties shall have shared parental responsibility for the minor children. The Husband shall be designated the primary residential parent of the minor children. The Wife shall be entitled to reasonable and liberal visitation of both minor children, with the minimum being set forth in the standard St. Lucie County visitation schedule.

E. Child support is agreed to by the parties as specifically set forth in the Marital

Settlement Agreement. The Wife shall pay child support in the amount of \$350.00 per month, commencing on June 1, 1997, directly to the Husband.

F. The parties have entered into a Marital Settlement Agreement dated June 11, 1997, resolving all issues, and disposing of all property and debts. The original Marital Settlement Agreement has been filed with the Court, and is hereby incorporated into the Final Judgment.

G. That any other claims by the Husband or Wife not otherwise incorporated by reference in the Final Judgment are hereby denied.

H. This Court reserves jurisdiction over the parties and over all matters contained in the Final Judgment as permitted by law for the purposes of enforcement and modification.

I. That the Wife's maiden name of Terri Lynn Scott is hereby restored.
