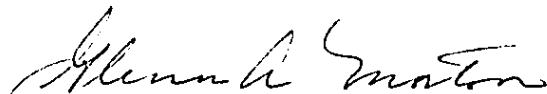

INDEMNIFICATION

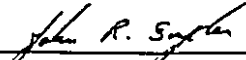
