## ARTICLES OF INCORPORATION OF CHAMPION PROPERTY MAINTENANCE, INC. A FLORIDA FOR PROFIT CORPORATION

#### **ARTICLE I - NAME OF CORPORATION**

A Florida for profit corporation named Champion Property Maintenance, Inc.(the "corporation") has been established and its principle office is 4502 Evers Place, Orlando, Florida 32811.

#### **ARTICLE II - PURPOSE**

The general purposes for which the Corporation is organized are:
