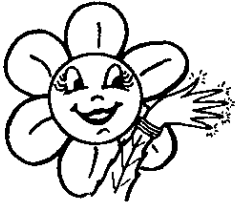

We recently received Document #P95000019943 stating that a new application for reinstatement would be required along with a penalty payment of \$750.00. This is the reason for our current correspondence.

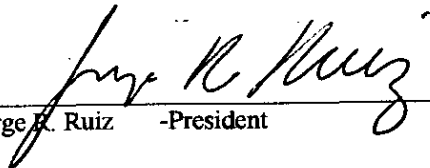
