ARTICLE I

NAME

The name of this Corporation is Yaté K. Cutliff, P.A. The address of this Corporation is 301 42nd Street North, St. Petersburg, Florida 33713-7421.

ARTICLE II

DURATION

This corporation shall have perpetual existence.

ARTICLE III

NATURE OF BUSINESS

This Corporation is being organized under Chapter 621 of the Florida Statutes, the Professional Service Corporation Act, for the sole and specific purpose of rendering professional services to the public that may be rendered by attorneys at law who are duly licensed or otherwise authorized to practice within the State of Florida.

ARTICLE IV

TERM OF EXISTENCE

This Corporation shall have perpetual existence unless sooner dissolved in accordance with the laws of the State of Florida.

ARTICLE V

CAPITAL STOCK




