**ARTICLE I**

**NAME OF CORPORATION**

The name of this corporation shall be:

**ARTICLE II**

**PRINCIPAL OFFICE**

**DURATION**

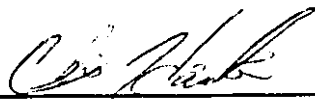

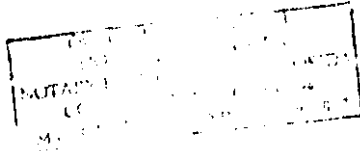
