ARTICLE I NAME

The name of the corporation shall be TIGHT LINE MASONRY, INC.

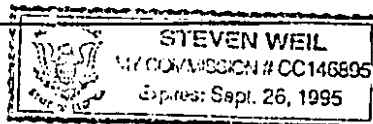
