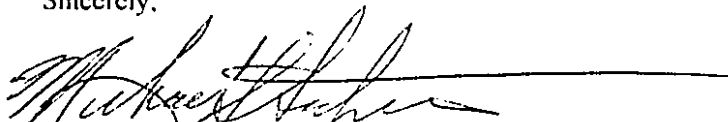

**ARTICLES OF INCORPORATION**

**ARTICLE I: NAME**

The name of this corporation shall be **JET NEWS AGENCY, INC.**

**ARTICLE II: DURATION**

This corporation shall commence existence upon the filing of these Articles of Incorporation by the Department of State and shall have perpetual existence unless sooner dissolved according to law.

**ARTICLE III: PURPOSE**

The purpose of this corporation to engage in any lawful business for which corporations may be incorporated under the laws of the State of Florida, including but not limited to the making and performing of contracts of any kind and description for the purpose of attaining any of the objects of the corporation, and to do and perform any and all things necessary incident to the lawful performing and carrying out of the business.

**ARTICLE IV: CAPITAL STOCK**

The amount of the capital stock for which this corporation is authorized to issue is **20** shares of **\$1.00** par value common stock.

**ARTICLE V: PRE-EMPTIVE RIGHTS**

Every shareholder, upon the sale for cash of any new stock of this corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his pro-rata share thereof, as nearly as may be done without issuance of fractional shares, at the price at which it is offered to others.

#### **ARTICLE VI: PRINCIPAL BUSINESS OFFICE, AND REGISTERED AGENT**

The principal place of business and street address of the corporation is **1022 N E 14th Street, Ocala, FL 34470**. The name of the initial registered agent of this corporation is **Michael A. Siefert**, street address, **Walkup and McGovern, 18 N W 3rd Avenue, Ocala, FL 34475**.

#### **ARTICLE VII: CORPORATION MANAGEMENT**

The business of this corporation shall be managed by the stockholders of the corporation rather than by a Board of Directors.

#### **ARTICLE VIII: STOCKHOLDERS**

The names and addresses of the stockholders of this corporation, who are of full age and who are citizens of the United States of America, and the number of shares of stock and the par value thereof are:
