ARTICLES OF INCORPORATION

OF

KIWI INVESTMENTS, INC.



ARTICLE I

NAME

The name of this corporation is Kiwi Investments, Inc. and its mailing address is 8320 Heritage Club Drive, West Palm Beach, Florida, 33412.

ARTICLE II

NATURE OF BUSINESS

This Corporation is being formed for the following purposes:

- a. To engage in any and all lawful business or activity permitted under the laws of the United States and the State of Florida.
- b. To generally have and exercise all powers, rights and privileges necessary and incident to carrying out properly the objects herein mentioned.
