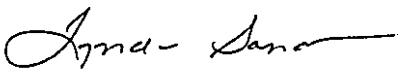

ARTICLES OF INCORPORATION  
OF

ARTICLE I - NAME

*The name of this corporation is J & E PHYSICAL THERAPY SERVICES, INC.*

ARTICLE II - NATURE OF BUSINESS

*This corporation may engage in any activity or any business permitted under the laws of the United States of America or the State of Florida.*

ARTICLE III - CAPITAL STOCK

*The maximum number of shares of stock that this corporation is authorized to have outstanding at any time is ONE THOUSAND (1,000) shares of common stock having a nominal or par value of \$1.00 per share.*

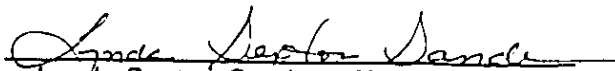

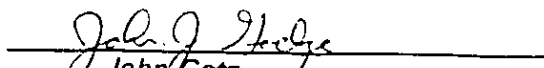
