#### ARTICLE I - NAME

The name of the corporation shall be ARROW ENTERPRISES OF SOUTHWEST FLORIDA, INC. The mailing address for the corporation is 5318 DeSoto Parkway, Sarasota, Florida 34.34.

#### ARTICLE II - DURATION

This corporation shall exist perpetually.

## ARTICLE III - PURPOSE

In the absence of fraud, no contract or other transaction between this corporation and any other corporation or any individual or firm shall be in any way affected or invalidated by the fact that any of the Directors or Officers of this corporation are interested in such contract or transaction, provided that such interest shall be fully disclosed or otherwise known to the Board of Director, in the meeting of such Board at which such contract or transaction is authorized or confirmed, and provided, however, that any such Directors of this corporation who are so interested may be counted in determining the existence of a quorum at any meeting of the Board of Directors of this corporation which shall authorize or confirm such contract or transaction, and any such Director may vote thereon to authorize any such contract or transaction with like force and effect as if he were not such Director or officer of such other corporation or not so interested.

#### ARTICLE X - REPLACING STOCK CERTIFICATES

The Board of Directors may, by resolution, provide for the issuance of stock certificates to replace lost or destroyed certificates.

#### ARTICLE XI - AMENDMENT

These Articles of Incorporation may be amended in any manner provided by law.


