# ARTICLES OF INCORPORATION ERS - REALTY PLUS, INC.

Stand Stands Allings EFFECTIVE DATE I, the undersigned, do hereby organize myself for the purpose of becoming a corporation for profit under the laws of the State Of Florida.

### ARTICLE I - NAME

The name of the corporation is ERS-REALTY PLUS, INC.
