ARTICLES OF INCORPORATION

OF

ROBERT ZARRANZ, N.D., P.A.

ARTICLE I - NAME

The name of this Corporation is ROBERT ZARRANZ, M.D., P.A. (hereinafter referred to as the "Corporation")

ARTICLE II - DURATION

This Corporation shall exist perpetually, commencing upon the filing of the Articles of Corporation by the Department of State.
