ARTICLE I

King Caterers, CORPORATION

Name

ARTICLE II

<u>Duration</u>

This corporation shall have perpetual duration beginning on March 9, 1995.

ARTICLE III

Purpose

The purpose or purposes for which the corporation is organized are to operate a bona fide restaurant, and to do all other things incidental to or connected with such business activities, and for the purpose of transacting any or all lawful business not specifically forbidden by Florida Corporation Laws or by other law, or by these Articles of Incorporation.

ARTICLE IV

Capital Stock

This corporation is authorized to issue One Hundred (100) shares of five dollars (\$5.00) par value Class A common stock, which shall be designated "Common Shares".

ARTICLE V

Preferences, Limitations and Relative Rights of Shares of Capital Stock

Section 1. Dividends:

The holders of record of the Common Shares shall be entitled to cash dividends when and as declared by the Board of Directors at the rate per share per annum and at the time and manner determined by the Board of Directors in the resolution authorizing such cash dividends.

Section 2. Voting Rights:

Except as otherwise provided by law, the entire voting power for the election of directors and for all other purposes shall be vested exclusively in the holders of the outstanding Common Shares.

ARTICLE VI

Initial Registered Office and Agent

ARTICLE VII

Initial Board of Directors

This corporation shall have one director initially. The number of directors may either be increased or diminished from time to time by the bylaws, but shall never be less than one. The name and address of the initial Director of this corporation is:

ARTICLE IX

Eylaws

The power to adopt, alter, amend or repeal bylaws shall be vested in the board of directors and the shareholders.

ARTICLE X

Cumulative Voting

At each election for Directors every shareholder entitled to vote at such election shall have the right to cumulate his votes by giving one candidate as many votes as the number of directors to be elected at that time multiplied by the number of his shares, or by distributing such votes on the same principal among any number of such candidates. Notice must be given by any shareholder to the president or vice president of said corporation of said corporation not less than twenty four hours prior to the time set for the holding of a shareholder meeting for the election of directors that said shareholder intends to cumulate his vote at said election.

ARTICLE XI

Shareholder Voting

Majority consent of the stockholders of the corporation shall be required for any shareholder action.

ARTICLE XII

Approval of Shareholders Required for Merger

The approval of the shareholders of this corporation to any plan of merger shall be required in every case, whether or not such approval is required by law.

ARTICLE XIII

Indemnification

The corporation shall indemnify any officer or director, or any former officer or director, to the full extent permitted by law.

ARTICLE XIV

Amendment

This corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation, or any amendments hereto, and any right conferred upon the shareholders is subject to this reservation.
