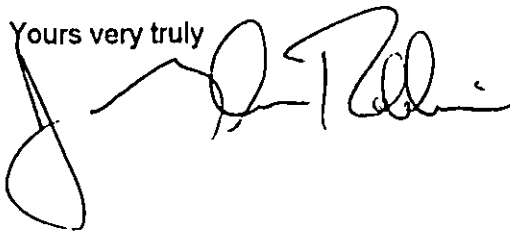

ARTICLE I-NAME

The name of this corporation is: JRJR ENTERPRISES, INC.

ARTICLE II-DURATION

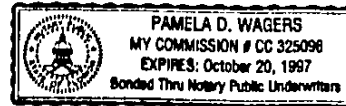

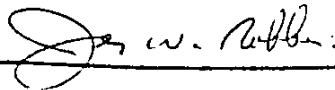

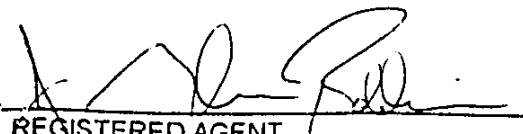
