**ARTICLES OF INCORPORATION**  
**OF**  
**ACCESS TRADING & SUPPLY INC.**

The undersigned incorporator to these Articles of Incorporation, a natural person competent to contract, hereby presents these articles of incorporation for the formation of a corporation under applicable laws of the State of Florida.

**ARTICLE I - NAME**

The name of this corporation shall be Access Trading & Supply Inc.

**ARTICLE II - NATURE OF BUSINESS**

The corporation may engage in any activity or business permitted under the laws of the United States and the State of Florida.

**ARTICLE III - CAPITAL STOCKS**

The maximum number of shares of stock that this corporation is authorized to have outstanding at any time is Five Hundred Shares (500) all of which shall be voting common stock of the par value of One Dollar (\$1.00).

To the extent permitted by law, said stock shall be issued pursuant to a plan under Section 1244 of the Internal Revenue Code of 1954, as amended, and a necessary action taken by the corporation to qualify the stock to be offer and issued under this plan as "Section 1244 Stock", as such term is defined in the Internal Revenue Code and the Regulations issued thereunder.

**ARTICLE IV - INITIAL CAPITAL**

The amount of capital with which this corporation shall begin business will not be less than Five Hundred (\$500.00) Dollars.

**ARTICLE IV - INITIAL CAPITAL**

**ARTICLE V - PREEMPTIVE RIGHTS**

Every shareholder, upon the sale for cash of any new stock of this corporation of the same kind, class, or series as that which he already holds, shall have the right to purchase his pro rata share thereof at the price at which it is offered to others.

#### **ARTICLE VI - TERM OF EXISTENCE**

This corporation is to exist perpetually.

#### **ARTICLE VII - INITIAL REGISTERED OFFICE AND AGENT**

The street address of the initial office of this corporation is 422 Beard Street, Tallahassee, Florida 32303.

#### **ARTICLE VIII - DIRECTORS**

The corporation shall have one (1) director initially. The number of directors may be either increased or diminished from time to time by the by-laws, but shall never be less than one.

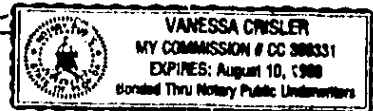
